

**DISTRICT OF LANTZVILLE
BYLAW NO. 86.1, 2012**

A BYLAW TO AMEND DISTRICT OF LANTZVILLE FIRE PROTECTION SERVICES BYLAW NO. 86, 2010

WHEREAS the Council may, by bylaw, pursuant to the *Community Charter*, establish and regulate the activities of a Fire Department;

AND WHEREAS the Council may, by bylaw pursuant to the *Community Charter*, and subject to the *Fire Services Act* and the Fire Code Regulations made under it, establish regulations for the protection of persons and properties from fire;

Title

1. This Bylaw may be cited as “District of Lantzville Fire Protection Services Bylaw No. 86, 2010, Amendment Bylaw No. 86.1, 2012”.

NOW THEREFORE BE IT RESOLVED, that the Council of the District of Lantzville in open meeting assembled, hereby enacts as follows:

- A. **Item 32(a)** of “District of Lantzville Fire Protection Services Bylaw No. 86, 2010” is hereby amended to read as follows:

No person shall burn the following materials:

- prohibited materials set out in the *Open Burning Smoke Control Regulation* under the *Environmental Management Act* (British Columbia) as listed below:

asphalt and asphalt products	insulation	special waste
biomedical waste	manure	tar paper
demolition waste	paint and paint products	tires
domestic waste (household material and food waste not including newspaper and cardboard)	plastics	treated lumber
drywall	railway ties	
fuel and lubricant containers	rubber	

- Items included as part of the District of Lantzville Curbside Recycling and Green Bin Program as listed below:

cardboard	newspapers and mixed papers	textiles, clothing, shoes and linens
food waste	rigid household plastic containers and bottles	
metal containers	soiled paper/paper packaging	

- B. **Schedule 'B' Burning Permit** of “District of Lantzville Fire Protection Services Bylaw No. 86, 2010” is hereby amended as follows:

1. By deleting Schedule 'B' Burning Permit as adopted, and replacing it with Schedule 'B' Burning Permit, attached to and forming part of this Amendment Bylaw.

READ A FIRST TIME this 15th day of October, 2012.

READ A SECOND TIME this 15th day of October, 2012.

READ A THIRD TIME this 15th day of October, 2012.

SCHEDULE B BURNING PERMIT

An incinerator must be made of a non combustible material with the opening for emitting products of combustion to the atmosphere covered with a screen or equivalent device with openings no larger than 2 1/2 cm x 2 1/2 cm (1" x 1").

- In accordance with the conditions of Burning Permits, failure to comply with the conditions of the permit will result in fines being imposed by the District in accordance with the following.

Bylaw No. 86 states in part...

- 38. Any person who contravenes this Bylaw is liable upon summary conviction to a minimum fine of \$500 and a maximum fine of \$10,000 and the cost of prosecution. Every day during which there is an infraction of this bylaw shall constitute a separate offence.**

PROHIBITED MATERIALS

The following material **will not** be burned in the "open air":

- prohibited materials set out in the *Open Burning Smoke Control Regulation* under the *Environmental Management Act* (British Columbia) as listed below:

asphalt and asphalt products	insulation	special waste
biomedical waste	manure	tar paper
demolition waste	paint and paint products	tires
domestic waste (household material and food waste not including newspaper and cardboard)	plastics	treated lumber
drywall	railway ties	
fuel and lubricant containers	rubber	

- Items included as part of the District of Lantzville Curbside Recycling and Green Bin Program as listed below:

cardboard;	newspapers and mixed papers;	textiles, clothing, shoes and linens.
food waste;	rigid household plastic containers and bottles;	
metal containers;	soiled paper/paper packaging;
