Stage 2 Water Restrictions Still in Effect

Restrictions are as follows:

Odd house numbers watering days are Tuesdays and Saturdays within permitted hours.

Even house numbers watering days are Thursdays & Sundays within permitted hours.

Watering is restricted to a maximum of **2 hours** per designated day between the hours of 7:00 – 9:00 am **OR** 7:00 – 9:00 pm.

Please note that watering restrictions only apply to those property owners who are on the District's community water system. However, we also encourage those with private wells to exercise water conservation.

Danger Trees

As we approach fall/winter, and with it, rain and at times, high



winds, property owners are being asked to ensure that trees on their property are healthy and vibrant. Large taller trees may pose safety risks to you and your neighbours. If you suspect that a tree on your property may be considered hazardous you may wish to retain the services of a professional arborist to conduct such an assessment.
