

# **District of Lantzville Community Update**

Five Year Financial Plan, Parcel Tax Rolls Water Negotiations, Fire Department Garage Sale, & District Staffing

## Five Year Financial Plan (2014-2018)

Following Council's discussions during its Committee of the Whole and Regular Council meetings to date, the District's Five Year Financial Plan process is nearing completion and Council will consider adoption of the Plan in April. Since the last Community Update, Council has approved the following items for inclusion in the Financial Plan:

- Reduction of 2014 tax increase to 2.5% from 4%
- Approval of the asphalt (\$310,000) and culvert replacements (\$300,000) - capital projects
- One-time contribution to the Fire Truck Replacement Reserve of \$64,000

Council invites the public to provide feedback either in writing or by attending upcoming Council meetings. An overview of the 2014-2018 Financial Plan will be presented at the April 14th, 2014 Regular Council Meeting.

#### **Parcel Tax Rolls**

The District wishes to advise residents that the Parcel Tax Rolls are now available for inspection at the District of Lantzville offices located at 7192 Lantzville Road, Lantzville, BC between the hours of 8:00 a.m. and 4:00 p.m., Monday - Friday, except statutory holidays. A person who owns a parcel included on the Parcel Tax Rolls may request an amendment based on one or more of the following:

- (a) there is an error or omission respecting a name or address on the parcel tax roll
- (b) there is an error or omission respecting the inclusion of a parcel
- (c) an exemption has been improperly allowed or disallowed

A request by the property owner for an amendment must be submitted in writing to the District of Lantzville on or before April 11, 2014.

#### <u>Municipal Roads, Facilities & Trails – OCP Map 6</u>

Council is considering an amendment to the "District of Lantzville Official Community Plan Bylaw No. 50, 2005" which stems from recommendations made in the Transportation Review the District conducted last spring. The amendment bylaw will essentially update Map No. 6 "Municipal Roads, Facilities and Trails" in addition to making two housekeeping changes to the text regarding the goal of improving roads, pedestrian and bicvcle mobility. Public Information Meetings were held on February 26<sup>th</sup>, following which Council, after making further amendments to the map as a result of staff and public feedback, proceeded to give second reading to the amendment bylaw. As per legislative requirements, a Public Hearing will now be held on the proposed amendment bylaw on **Monday, April 14<sup>th</sup>, 2014** beginning at 7:00 p.m., at the District Office.
