Please note that the deadline to make payments and submit Home Owner Grants without penalty is Wednesday, July 2nd by 4:00 pm. Postmarks are not accepted as proof of payment.

2014 Financial Plan – Capital Projects

The District's 2014 – 2018 Financial Plan was adopted by Council on April 28, 2014. Some of the capital projects you can expect to see in process over the next few months include:

- Road Resurfacing (Millard, Shangri-la, Mrus and Hall Roads)
- Watermain Replacement Lancrest Terrace
- Culvert Replacement Superior Road at Knarston Creek

Please note that some of these projects may impact traffic flow, etc. The District will make every effort to provide notice of these impacts so residents may plan accordingly.

Traffic Notes – Water Main Construction

Work on the watermain replacement along Lancrest Terrace began on May 7, 2014 and is on schedule! The installation of the watermain itself is nearly complete. Works still to be completed include the installation of individual service lines, disinfecting, testing, and service connections. At this time the District would like to remind everyone to please keep an eye out for the traffic control people and thank everyone for their cooperation. Council Update - In May, Council:

- adopted Official Community Plan Bylaw No. 50, 2005, Amendment Bylaw No. 50.5, 2014 amending OCP Map 6 and text changes
- adopted Freedom of Information and Protection of Privacy Bylaw No. 109, 2014
- gave Council Size Reduction Bylaw No. 110, 2014 first two readings and instructed staff to provide a report at the September 8, 2014 regular Council meeting to consider third reading and to establish the referendum question to be placed before the voters with the ballot for the general local election scheduled for November 15, 2014
- adopted Zoning Bylaw No. 60, 2005 Amendment Bylaw No. 60.29, 2014 to permit market gardening as a home-based business
- gave first two readings to Zoning Bylaw No. 60, 2005, Amendment Bylaw No. 60.30, 2014 (6290 Phantom Road), and scheduled the public hearing for Monday, June 9, 2014 at 7:00 pm at the District Office, 2nd Floor, 7192 Lantzville Road, Lantzville, BC
- approved Development Permit Application No. 3060.20.14114 - 6290 Phantom Road for land alteration, future residential development and subdivision within the Steep Slopes Protection Development Permit Area, with general requirements
- authorized a member of Council and three staff to attend the Provincial Earthquake Preparedness Consultation Community Session in Nanaimo
- received the Annual Development Cost Charges Activity Report for information
- approved the Statement of Financial Information for the year ended December 31, 2013.

Village Commercial Core Improvement Plan – Under Construction!

The Village Commercial Core Improvement Plan continues to develop - through the collaboration of a committee of residents and stakeholders as well as staff. In January, residents provided input at an evening event exploring building and streetscape character preferences. In late February, a design workshop was held, and the Committee drafted two potential concepts for streetscape upgrades and pedestrian improvements. These concepts, and some of the other ideas that were captured at that workshop, are available at www.lantzville.ca. Since then, staff and the Committee have been working on drafting the broader plan, which will provide smaller and larger improvement project priorities and include a policy framework to guide future development within the commercial core area. Key areas include circulation, form and character, gathering places, and beautification. Following the completion of the draft, staff and the Committee looks forward to bringing the proposed plan forward for community feedback, leading to a recommendation to Council. Committee meetings are open to the public, and the Committee welcomes your ideas for enhancing the commercial core. Toilet Rebate Program

Council resolved to continue the Toilet Rebate Program to reduce water consumption! Visit the District website or office for the brochure detailing how residents or property owners connected to the community water system can apply for a rebate for replacing up to two toilets with new low flush or dual flush models.

Bylaw Reminders

Fireworks Restrictions – Permit Reminder – A permit from the District Office and approved by the Fire Chief, is required *before* fireworks can be discharged. Fire crackers are not permitted at any time.

Open Burning — Open burning (fire piles on the ground) is not permitted within the District limits from May 15th to October 15th. Incinerator use is permitted at this time but could be closed at any time, as conditions dictate. Rules apply to incinerator use, including obtaining a free permit at the District Office *before* burning, burning limited to Fridays and Saturdays from dawn to dusk only, etc. *Note: Incinerators must be screened with a mesh no greater than approximately 1 inch and should always be burned as hot as possible. This helps to reduce smoke and ash.* Permits are subject to cancellation due to safety hazard, non-compliance, or wind conditions. Stage 1 Watering Restrictions – Effective May 1st **Are you Odd or Even?** Residential addresses may water lawns for a maximum of 3 hours between the hours of 6:00 am-10:00 am **OR** 6:00 pm-10:00 pm on the following days:

- Odd-numbered addresses on odd-numbered days
- Even-numbered addresses on even-numbered days

Please note that watering restrictions only apply to those properties that are on the District's community water system. However, we also encourage those property owners on individual private wells to also exercise water conservation measures.

SCHEDULE CHANGE - FOOD WASTE, GARBAGE AND RECYCLING REMINDER

Your regular collection day changes when there is a statutory holiday. Therefore, after the garbage and food waste collection on Monday, June 30th, collection resumes on Tuesday, July 8th with recycling and food waste pick-up, and continues on Tuesdays until the next statutory holiday.
