Council Update - In July, Council:

- awarded a \$266,650.65 contract to David Stalker Excavating Ltd. for Superior Road culvert replacement
- awarded a total of \$257,276.25 in paving contracts to Lafarge Canada Inc dba Hub City Paving for Shangri-La and Hall Roads and Millard Drive Reconstruction
- adopted Municipal Ticket Information Bylaw No. 100, 2012, Amendment Bylaw No. 100.1, 2014 to enable issuing tickets for additional bylaw offences
- adopted Respectful Workplace (Bullying & Harassment) Policy No. 5005-2 and Complaint Resolution Policy No. 5005-3, as required under WorkSafe BC legislation
- authorized the closure of Lantzville Road from 7113 Lantzville Road to Lantzville School Road from 9:45 am to 11:00 am on Saturday, September 6, 2014 to facilitate the Minetown Day parade
- authorized the closure of Lantzville Road from Tweedhope Road to Huddlestone Road from 10:00 am to 11:30 am on Saturday, August 9, 2014 to facilitate the parade from the Legion to Huddlestone Park for the new Cenotaph dedication ceremony

2014 is a General Local Election Year!

You are eligible to vote in the District of Lantzville municipal election, if on Voting Day you are:

- √ a Canadian citizen;
- √ age 18 or older;
- ✓ a resident of BC for at least the past 6 months;
- ✓ a resident of the District of Lantzville OR a nonresident owner (a person, not a corporation and the one owner designated by the owners to vote, if more than one owner) of property in the District of Lantzville, for at least the past 30 days; AND
- not disqualified by law from voting.

Mark **Saturday**, **November 15**, **2014**, on your calendar to vote at Costin Hall, 7232 Lantzville Road to elect your Mayor (1) and Councillors (6). All electors are eligible to vote at Advance Voting opportunities on: **Wednesday**, **November 5**, **2014 and Wednesday**, **November 12**, **2014** at the District Office, 7192 Lantzville Road – 2nd Floor. Voting hours each voting day are 8:00 am – 8:00 pm. Can't attend on a Voting Day? Sign up for Mail Ballot Voting. Mail ballots will be available for pickup in early November and must be received by the District prior to the Voting Place closing at 8:00 pm on General Voting Day – November 15th.

Nomination packages will be available for pick-up at the District Office beginning on Friday, August 29, 2014 for individuals interested in running for either Mayor or Councillor. The Nomination Period is from 9:00 am, September 30, 2014 until 4:00 pm, October 10, 2014. Recent Provincial legislation changes include extending the term of office to a four-year term. Other changes affect campaign financing and advertising. Bylaw Reminders

Open Burning — Open burning (fire piles on the ground) is not permitted within the District limits from May 15th to October 15th. Incinerator use is permitted during this period but can be closed at any time, as conditions dictate which is what occurred in July. A FIRE BAN was declared in Lantzville July 18, 2014 due to the extreme dry forest conditions. This means that no burning is permitted until the ban is lifted. This applies to any open fire including campfires and incinerator burning. STAGE 3 Watering Restrictions Effective July 15th *Are you Odd or Even?* You may water for a maximum of **2 hours** per designated day, between the hours of 7:00 am-9:00 am **OR** 7:00 pm-9:00 pm on the following days at properties with:

- Odd-numbered addresses on Tuesdays
- Even-numbered addresses on Thursdays

Watering restrictions include sprinkling, irrigating, and all outdoor washing. Please note that watering restrictions only apply to those property owners who are on the District's community water system. However, we also encourage those property owners on individual private wells to also exercise conservation measures when it comes to water usage. By adhering to these water restrictions you will assist in stabilizing our supply of potable water for drinking, household use and fire protection!
