

### 2014 is a General Local Election Year!

Eligible electors can vote on **Saturday, November 15, 2014** at Costin Hall, 7232 Lantzville Road to elect your Mayor (1) and Councillors (6), or vote at Advance Voting opportunities on: **Wednesday, November 5 and 12, 2014** at the District Office, 2<sup>nd</sup> Floor - 7192 Lantzville Road. Voting hours each day are 8:00 am - 8:00 pm. Can't attend on a Voting Day? Sign up to vote by mail!

Are you on the Voters List? If not, you may register at the District Office until September 23, 2014 or at the time of voting. Bring at least two pieces of identification (one must have your signature) to register to vote. Visit www.lantzville.ca for a list of acceptable identification.

Interested in running for the office of Mayor or Councillor? Nomination packages are available for pick-up at the District Office. The Nomination Period is from 9:00 am, September 30, 2014 until 4:00 pm, October 10, 2014. Recent Provincial legislation changes include extending the term of office to a four-year term, and changes that affect campaign financing and advertising.

#### **Traffic Notes – Under Construction!**

Motorists and pedestrians, please allow extra time, exercise caution, and observe directions given by traffic control personnel when in areas scheduled for roadwork and construction this September.

The Superior Road culvert replacement project at Knarston Creek started August 11<sup>th</sup> and is scheduled to complete by September 19<sup>th</sup>.

### **Bylaw Reminders**

**Open Burning** – The FIRE BAN declared in Lantzville July 18, 2014 due to the extreme dry forest conditions, continues. This means that no burning is permitted until the ban is lifted. This applies to any open fire including campfires and incinerator burning. Monitor the District's website for more information on the FIRE BAN. When weather permits, the campfire ban may be lifted but the open burning ban will remain in effect, as it does every year, until October 15<sup>th</sup>. ## STAGE 3 Watering Restrictions Effective July 15<sup>th</sup>

Thank you for complying with the watering restrictions – please continue to do so – and watch for announcements regarding any changes. Under the current Stage 3, you may water for a maximum of **2 hours** per designated day, between the hours of 7:00 am-9:00 am **OR** 7:00 pm-9:00 pm on the following days at properties with:

- Odd-numbered addresses on Tuesdays
- Even-numbered addresses on Thursdays

Watering restrictions include: sprinkling, irrigating, and all outdoor washing. Please note that watering restrictions only apply to those property owners who are on the District's community water system. However, we also encourage those property owners on individual private wells to also exercise conservation measures when it comes to water usage. By adhering to these water restrictions you will assist in stabilizing our supply of potable water for drinking, household use and fire protection!

**School Zones** – In anticipation of the new school year for public and independent schools, please exercise extra caution when driving in or near school zones and playgrounds, and watch out for children. When a school is in session, a 30 km/h school zone speed limit is in effect from 8:00 am to 5:00 pm every school day.
