Happy Canada Day!

The District Office will be closed on Wednesday, July 1, 2015 for Canada Day. The office will reopen on Thursday, July 2, 2015 at 8:00 am.

- adopted Financial Plan Bylaw No. 116, 2015
- adopted Tax Rates Bylaw No. 117, 2015
- rescinded Policy 5002-1 Cost of Living (COLA) Policy for Exempt Staff for any new exempt employees hired
- resolved to develop a management bylaw for exempt staff to establish terms and conditions of employment
- approved the audited financial statements for the year ended December 31, 2014, as presented
- approved the amended Statement of Financial Information for the year ended December 31, 2014
- appointed Councillors Haime and Coulson as the District representative and alternate, on the Vancouver Island Regional Library Board of Trustees
- appointed Councillor Coulson as Council's liaison to the Seaside Community Society
- appointed Councillor Coulson as alternate municipal director on the Regional District of Nanaimo Board
- appointed Councillor Coulson as Acting Mayor and Councillor Haime as alternate for the period June to September 2015 if the Mayor is unavailable
- appointed Jim Dias as Interim CAO, Deputy Director of Corporate Administration, Deputy Director of Financial Services and Approving Officer eff. June 1st
- appointed C. Douglas Lang as Interim Director of Financial Services effective June 3, 2015
- appointed Trudy Coates and Lynn Ketch as the 2015 By-election Chief Election Officer and Deputy CEO
- authorized conducting four 2-hour bicycle road safety and maintenance workshops for children
- authorized the purchase and installation of one bike stand and one garbage can at the District Office, and one bike stand at Costin Hall
- approved a Development Variance Permit for a height variance for a new dwelling at 7040 Dickinson Road and denied a variance for an accessory building
- authorized a Development Permit for 7386 Sunbury Road for a new house with decks and patios
- authorized the Mayor to execute the certificate of transfer of the cenotaph ownership from the Royal Canadian Legion Br 257 to the District of Lantzville

Invasive Knotweeds

Knotweed is an invasive alien species originally from Asia. It grows vigorously, impacting native ecosystems, and it can cause serious damage to foundations, driveways and septic systems. Cutting, mowing or digging up knotweed doesn't work because it spreads by roots and one small fragment can lead to more plants. If you think you have knotweed on your property, call a professional for assistance. Contact the District Office to report knotweed on public property. Mail ballots may be available for pickup or delivery starting the week of July 20th and must be returned and received by the CEO prior to the Voting Place closing at 8:00 pm on General Voting Day on Saturday, August 8th.

Bylaw Reminders

Burning Ban in Effect – On June 10, 2015, the Fire Chief declared a burning ban for the District of Lantzville. This means that no burning is permitted until the ban is lifted. This applies to any open fire including campfires and incinerator burning. Be Proactive. Be Safe. Be Ready! Remember, it just may be you who spots smoke! Program your phone to assist you in an emergency:

STAGE 2 Watering Restrictions Effective June 1st *Are you Odd or Even?* You may water for a maximum of **2 hours** per designated day, between the hours of 7:00 am-9:00 am **OR** 7:00 pm-9:00 pm on the following days at properties with:

- Odd-numbered addresses on Tuesdays and Saturdays
- Even-numbered addresses on Thursdays and Sundays.

Watering restrictions include sprinkling, irrigating, and all outdoor washing. Please note that watering restrictions only apply to those property owners who are on the District's community water system. However, we also encourage those property owners on individual private wells to also exercise conservation measures when it comes to water usage. By adhering to these water restrictions you will assist in stabilizing our supply of potable water for household use and fire protection!

Streets – The Traffic & Parking Regulations Bylaw No. 28 prohibits parking a vehicle or trailer on a street to display a sign, or to sell the vehicle. It also prohibits posting advertisements or posters on streets or utility poles. *Some exceptions apply.* Keep our streets clean!

FOOD WASTE, GARBAGE AND RECYCLING SCHEDULE CHANGE REMINDER

Your regular collection day changes when there is a statutory holiday. Therefore, after the garbage and food waste collection on Tuesday, June 30th, collection resumes on Wednesday, July 8th with recycling and food waste pick-up, and continues on Wednesdays for the month of July, until the August 3rd statutory holiday (BC Day), after which pick-up is on Thursdays.

HAPPY BC DAY! The District Office will be closed on Monday, August 3, 2015 for the BC Day holiday. Regular hours (8:00 am - 4:00 pm) will resume on Tuesday, August 4, 2015.
