Bylaw Reminders - Outdoor Burning

From October 16th to May 14th, residents are permitted to burn in their backyards without a permit. Conditions apply. Confirm...before you burn! Call Ministry of Environment at 1.888.281.2992 and follow the prompts to hear Environment Canada's daily ventilation index for Central Vancouver Island to confirm if burning is permitted. Outdoor burning is restricted when the index is POOR or FAIR. The conditions must be GOOD on the day you burn and GOOD or FAIR the following day in order to burn per the burning bylaw. Of note, a clear sunny day isn't a reliable indicator that you can burn you must check the ventilation index. Be considerate of your neighbours when burning so you don't impact their daily routine or health. Burn materials hot, infrequently and ONLY when venting permits so the smoke goes straight up. Council Update - In February 2016, Council:

- authorized the early release of funds for Rotary Park improvements (playground equipment replacement \$37,000 and mountain bike skills circuit \$39,000)
- endorsed the Parks and Recreation Commission recommendation that Council proceed with selection and appointment of Commission members for the current and future vacancies without referral
- adopted Policy 3005-1 Accepting One Development Permit Application for Multiple Property Owners
- authorized Aspengrove School to hold a Charity Bike Ride from 10:00 am to 1:00 pm, Saturday, May 14, 2016 on a route along specified streets and the E&N Trail, subject to notice, traffic control and insurance
- approved \$9,000 for The Port Theatre Society in 2016
- instructed staff to report on pedestrian crossing options for a crossing at Dickinson Road between the bottom of the Trail at Dickinson Road and Oar Road
- deferred discussion of the \$28,890 Special Request to complete pathway adjacent to Huddlestone Park, to the 2017 budget discussions in consideration of potential participation with the Royal Canadian Legion
- instructed staff to begin OCP review process in 2016 and approved \$55,000 in 2016 and \$55,000 in 2017
- instructed staff to establish an operating reserve fund to fund the next OCP review process, contributing \$15,000 per year beginning in 2018
- adopted Policy 3000-8 for awarding the Freedom of the Municipality Honour for distinguished service
- approved \$7,000 in 2016 for completion of the design of the Lantzville Nanaimo Water Interconnection
- approved \$15,000 in 2016 for Council meeting recording and sound equipment and \$850 ongoing operating costs
- gave Financial Plan Bylaw No.116, 2015, Amendment Bylaw No. 122, 2016 first three readings
- directed staff to incorporate the Watering Restrictions adopted regionally into the Water Conservation Plan
- approved a Development Permit for 7468 Lantzville Road for a new dwelling and a swimming pool
- appointed John Dunn to the Parks and Recreation Commission for a term ending December 31, 2018

*Definitions:

- Micro and Drip Irrigation:
 - "Delivers water to the root zone of the plants and uses less than 20 gallons per hour at less than 25 psi."
- Hand-watering:
 - "Delivering water by hose with spring-loaded nozzle shut-off device or hand-held container."

Note: We encourage all residents to voluntarily conserve water at all times. Water restrictions only apply to those property owners who are on the District's community water system. However, we also encourage those property owners on individual private wells to also exercise conservation measures when it comes to water usage.
