## OCP Update & Water Master Plan

This past Fall, we've had the opportunity to listen to the Lantzville community's ideas and opinions about the future of land use and water, shared at Minetown Day, through Community Workshop #1, and during the Kitchen Table Meetings. Based on this input, a short list of options have been developed for public consideration.

COMING UP: On Wednesday, January 18, 2017 we'll be presenting these options at Community Workshop #2. Join us at Costin Hall from 6:00 pm to 8:30 pm to:

- Review and discuss land use options for the Village Core, key potential development areas, and the community as a whole
- Look at the relationship between short-listed land use options and provision of water servicing to unserved neighbourhoods.

Following the January 18<sup>th</sup> workshop, the community-wide survey will be launched to collect public opinions on the options for land use and water service in the community. The input received through this survey will be used to inform the Draft OCP Update and Water Master Plan coming forward in Spring 2017.

**Council Update** – In December 2016, Council:

- designated Councillor Bob Colclough as the District of Lantzville contact for the Federation of Canadian Municipalities' Canada 150 Community Leaders Network
- authorized renewing the agreements for the Regional District of Nanaimo to provide services for the District of Lantzville for a term ending December 31, 2018, including contracts for Animal Control Services, Building Inspection, Bylaw Enforcement, Emergency Planning Services, and GIS and Mapping Services
- authorized the purchase of a computer network server and installation, and costs to re-purpose the replaced server (total cost up to \$13,500 plus taxes)
- instructed staff to bring forward Council Procedure Bylaw amendments for Council consideration to apply Council procedures to committees, and to describe procedures for a Council member returning to a meeting for the next item after declaring a conflict.

Early in 2017, Council of the District of Lantzville will consider applications for discretionary Grants in Aid for the 2017 calendar year. Funds available for grants are limited and subject to budgetary constraints. The primary purpose is to provide financial assistance to an organization for a specific project or event that benefits the residents of the District of Lantzville. The organization should be registered as a Society (or belong to a parent Society) under the laws of BC and/or Canada. Preference will be given to locally based organizations whose efforts are community based in nature. Council will not grant monies to a 'for profit' organization. Applications must be completed and submitted to the District Office, no later than *Wednesday, February 1, 2017*. ## BYLAW REMINDERS

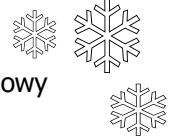
### Fireworks Restricted - by Permit Only

The District of Lantzville requires that a permit be obtained from the District Office and approved by the Fire Chief *before* fireworks can be discharged.

**No Water Restrictions** in effect until further notice.

### Winter is here! Are you prepared?

At this time of year we have maximum darkness, rain, and sometimes slippery or snowy conditions.



**Pedestrians and drivers:** Please dress and drive to suit the conditions. Be visible. Carry a flashlight. After a snowfall, expect minor delays, allow extra travel time and park off the road to allow plows and emergency vehicles space to pass. Don't abandon your car if it gets stuck, and please do not leave basketball hoops or equipment on the road right of way. This will allow better snow removal service in our neighbourhoods. Our contract with Windley Construction does identify which roads receive priority clearing during periods of heavy snowfall versus others. Our contractor's first priority is to clear 'Primary' roads, as follows:

- 1. Primary Roads** – Aulds, Dickinson, Lantzville, Superior and Ware (regional transit, school, and emergency access required).
- 2. Secondary Roads** – Examples of secondary roads are Caillet Road, Harwood Drive and Southwind Drive.

If snowfall is ongoing, the contractor will return to those Primary roads if snow continues to accumulate and, as a result, may not make it to Secondary roads, cul-de-sacs and side roads for twenty-four hours. If possible, stay off the roads during a snowfall and for safety reasons, do not use the roads as playgrounds. Be safe!



## FOOD WASTE, GARBAGE AND RECYCLING SCHEDULE CHANGE

Your regular collection day changes when there is a statutory holiday. Therefore, after the recycling and food waste collection on Wednesday, December 28, 2016, collection resumes on Thursday, January 5, 2017 with garbage and food waste pick-up, and continues on Thursdays until after Family Day in February 2017. Place your container at the curb by 8:00 am.

**Extra garbage from the holidays?** Did you know that you can place a maximum of two extra garbage containers curbside on your collection day? Purchase a garbage tag (\$3.00) at the District Office, RDN Office (6300 Hammond Bay Road), Jingle Pot Store, Country Grocer (Chase River) or Quality Foods (Nanose Bay), for each additional garbage container (max.2/collection day).
