### Five Year Financial Plan 2017-2021

Council commenced its review of the 2017-2021 Financial Plan at the January 16, 2017 Committee of the Whole meeting, when staff provided an introduction to the 2017-2021 Five Year Financial Plan that included the general operating fund and requests from District departments for non-core special request items. Discussion of these items will continue at the Committee of the Whole meetings on March 6 and 20, 2017. Council invites residents to provide feedback either in writing or by attending upcoming Committee of the Whole meetings. Financial Plan Committee of the Whole meetings are scheduled as follows:

The 2017-2021 Financial Plan Bylaw and related Tax Rates Bylaw must be adopted by Council before May 15, 2017.

### **Council Update** – In February 2017, Council:

- adopted Miscellaneous Fees and Charges Amendment Bylaw No. 138, 2017 to increase tax certificate, garbage collection and food waste container fees
- consented to the RDN Board's adoption of Regional District of Nanaimo Pump & Haul Local Service Establishment Repeal Bylaw No. 1752, 2017
- accepted the Regional District of Nanaimo Regional Growth Strategy Bylaw No. 1615.01, 2016
- instructed staff to amend the Financial Plan to include a public consultation process/development of a long range plan for Costin Hall and Heritage Church in 2018 (\$10,000)
- approved \$20,000 in the 2017-2021 Financial Plan for Asset Management Services for immediate release
- approved Development Permit Application No. 3060-20-DP16-005, with variances, to accommodate the construction of a single family dwelling on Strata Lot 4, Strata Plan 436, Lantzville Road
- appointed Trudy Coates as Acting Chief Administrative Officer (CAO) pending the appointment of a new CAO
- gave third reading to Bylaw No. 60.34 to amend the Zoning Bylaw to change 6411 Manhattan Way from Rural 1, Subdivision District D (2.0 ha, minimum parcel size) to Subdivision District F (1.0 ha. minimum parcel size)
- instructed staff on amendments to the draft 2017-2021 Financial Plan for Non-Core Special Request Items and Capital Budget Summary that Council will consider in the Financial Plan Bylaw to be adopted before the May 15, 2017 deadline
- approved a water bill adjustment for 7036 Dickinson Road

We will use the information collected from the completed surveys to bring forward drafts of the OCP Update and the Water Master Plan at a community event for review and feedback.

Every home in BC is required by law to have a working smoke alarm. Test smoke alarms at least once a month using the test button, maintain and replace following the manufacturer's instructions.

#### BYLAW REMINDERS

Outdoor burning - From October 16<sup>th</sup> to May 14<sup>th</sup>, residents are permitted to burn in their backyards without a permit. Conditions apply. Confirm – before you burn! Call Ministry of Environment at 1.888.281.2992 and follow the prompts to hear Environment Canada's daily ventilation index for Central Vancouver Island to confirm if burning is permitted. Outdoor burning is restricted when the index is POOR or FAIR. The conditions must be GOOD on the day you burn and GOOD or FAIR the following day in order to burn per the burning bylaw. Of note, a clear sunny day isn't a reliable indicator that you can burn – you must check the ventilation index. Be considerate of your neighbours when burning so you don't impact their daily routine or health. Burn materials as hot as possible (to reduce smoke and ash), burn infrequently and ONLY when venting permits so the smoke goes straight up.

In addition to the weather conditions, fire supervision, size of fire and burn materials are also regulated. Follow the regulations in Bylaw No. 86 and check out Bylaw No. 86.1 before you burn for a list of prohibited materials. An open air fire (aka burn pile, bonfire, backyard fire) is for yard clean-up - no prohibited materials may be burned. **Speed limits keep our neighbourhoods safe** – The speed limit on streets in Lantzville is 50 km/h except where posted otherwise, e.g. portion of Lantzville Road 30 km/h. Remember to *SLOW DOWN* in residential areas and near school zones, crosswalks, and posted Children Playing signs, e.g. Southwind Drive. School Spring Break is March 20-31, 2017. Please be especially cautious on all streets during Spring Break, and in school zones when children return to school following Spring Break. When a school is in session, a 30 km/h school zone speed limit is in effect from 8:00 am to 5:00 pm every school day.

**Spring is Coming...planning a new garden or landscaping?** Conserve water in your new garden with '*xeriscaping'* – specifically designed for minimal watering! It saves you some work and reduces water demands during the summer. This style of garden features native plants and shrubbery, cacti, succulents, ornamental grasses, and drought-tolerant turf grasses. Other things to consider when planning a new garden or landscaping:

- confirm your property line to ensure your works are not encroaching on your neighbours or a right of way
- reduce wildfire risk within wildland/urban interface reduce fuel (e.g. brush)
- confirm if your property is in a Development Permit
  Area for steep slope or sensitive ecosystem
  protection. Contact the Planner at the District Office.
