## Five Year Financial Plan 2017-2021

Council began its review of the 2017-2021 Financial Plan at the January 16, 2017 Committee of the Whole (COTW) meeting, when staff provided an introduction to the Plan. Discussion of the Plan, reports and Council motions to provide direction regarding the Plan continued at the COTW and Council meetings in January, February and March. The March 20, 2017 COTW meeting included a presentation to the public and another opportunity for public input on the Financial Plan. First three readings of the 2017-2021 Financial Plan Bylaw and the related Tax Rates Bylaw will be considered at the April 10, 2017 Council meeting, and must be adopted by Council before May 15, 2017. # Council Update - In March 2017, Council:

- confirmed there is no interest in undertaking any new regional service functions at this time
- approved a \$2,000 grant in aid to the Lantzville Historical Society for computer equipment and table
- directed staff regarding the rates and tax multiples to include when preparing the 2017 Tax Rate Bylaw for Council's consideration
- authorized Councillors Colclough and Swain to attend the Association of Vancouver Island and Coastal Communities Convention April 7-9, 2017 in Campbell River and three members of Council (TBD) to attend the Union of BC Municipalities Convention September 25-29, 2017 in Vancouver
- awarded the Lantzville Road Interconnection Main Project (\$633,360) to Copcan Civil Ltd. and authorized the early release of funding for the project (\$736,000)
- directed staff to issue a media release regarding social media comments by Mayor Haime about the Nanaimo Events Centre
- instructed staff to issue a media release regarding the District of Lantzville receiving a grant towards the Phase III Sanitary Sewer Collection System
- authorized entering into a Provincial agreement to receive the federal/provincial government New Building Canada Fund – Small Communities Fund grant (\$4,373,332) towards the Phase III Sanitary Sewer Collection System project, and immediate release of funds required in the Financial Plan
- adopted Zoning Bylaw Amendment No. 60.34 to rezone 6411 Manhattan Way to Subdivision District 'F'
- gave Development Cost Charge Reserve Fund Expenditure Bylaw No. 142 first three readings
- approved an additional \$100,000 in the 2017 Financial Plan for snow removal
- directed staff to install a speed hump with crosswalk and signage at the intersection of Huddlestone and Lantzville Roads, funded from operations.

The District of Lantzville has partnered with the Broombusters Invasive Plant Society again this year to assist in controlling the alien invasive plant Scotch broom in our community. Help protect our environment from this



invasive alien plant and enjoy some time with fellow residents. Currently, the following Lantzville community broom cuts are scheduled:

- 1. Sunday, April 30<sup>th</sup> 9:30 am 11:30 am *Highway – along Lantzville Rd between Schook/Owen*
- 2. Wednesday, May 3<sup>rd</sup> 9:30 am 11:30 am As above – ongoing every Wed throughout season
- 3. Saturday, May 6<sup>th</sup> 9:30 am 11:30 am Petsmart – area between northbound merge & northbound highway
- 4. Saturday, May 13<sup>th</sup> 9:30 am 11:30 am *Highway southbound @ Ware Road*
- 5. Sunday, May 21<sup>st</sup> 9:30 am 11:30 am Highway southbound (north of Exit 29) meet at the end of Alger Road
- 6. Saturday, May 27<sup>th</sup> 9:30 am 11:30 am *E&N Trail maintenance Aulds Road end*

## BYLAW REMINDERS

Outdoor burning - From October 16<sup>th</sup> to May 14<sup>th</sup>, residents are permitted to burn in their backyards without a permit. Conditions apply. Confirm – before you burn! Call Ministry of Environment at 1.888.281.2992 and follow the prompts to hear Environment Canada's daily ventilation index for Central Vancouver Island to confirm if burning is permitted. Outdoor burning is restricted when the index is POOR or FAIR. The conditions must be GOOD on the day you burn and GOOD or FAIR the following day in order to burn per the burning bylaw. Of note, a clear sunny day isn't a reliable indicator that you can burn – you must check the ventilation index. Be considerate of your neighbours when burning so you don't impact their daily routine or health. Burn materials as hot as possible (to reduce smoke and ash), burn infrequently and ONLY when venting permits so the smoke goes straight up.

In addition to the weather conditions, fire supervision, size of fire and burn materials are also regulated. Follow the regulations in Bylaw No. 86 and check out Bylaw No. 86.1 before you burn for a list of prohibited materials. An open air fire (aka burn pile, bonfire, backyard fire) is for yard clean-up - no prohibited materials may be burned. Bylaw Enforcement Issues – Most bylaw enforcement issues are based on neighbourhood disputes. Many of these can be resolved by neighbours speaking civilly to each other about their concerns and seeking a resolution that meets both parties' interests. We always try and resolve bylaw complaints at the lowest level of intervention. It is typical for the bylaw officer to hear "Why didn't they just come and talk to me?" when we contact property owners about a possible contravention. It is always best to speak to your neighbour who is doing something you are concerned about when you are not agitated. Approach them in a friendly manner to voice your concern, not with a direct accusation that they have done something wrong. Good communication between neighbours builds better neighbourhoods!

## **Community Water System Maintenance**

Please note that the District of Lantzville will be conducting water main flushing (part of our annual routine maintenance) beginning on April 3rd for an approximate 4-week period to remove sediment and maintain good water quality. Flushing is achieved by releasing water in the mains through fire hydrants and stand pipes. The flushing causes the bubbling of air which may result in the discolouration of the water. While this does not affect the quality of drinking water, we recommend that laundry be done on weekends or evenings to avoid the possible discolouration of clothing.
