Happy BC Day! The District Office will be closed on Monday, August 7, 2017 for BC Day. Regular hours (8:00 am-4:00 pm) will resume on Tuesday, August 8th.

Traffic Control on Monday July 31st

On Monday, July 31, 2017, along the portion of Lantzville Road from Superior Road to Highway 19, vehicle traffic will be limited to special event participant, local resident and delivery traffic only, during the 7-hour period from 11:00 am to 6:00 pm. The Snaw-Naw-As will be welcoming to the Nanoose First Nation territory 75 of the Tribal Journeys 2017 canoes paddling (plus support vehicles driving) from throughout the Northwest to overnight en route to the event in Campbell River. The Snaw-Naw-As invite their neighbours to attend (pedestrian access only) their event beginning at 12:00 Noon on Monday, July 31st. Please use caution with the increased pedestrian traffic throughout the day, expect traffic delays and obey all directions given by traffic control. Lantzville Sanitary Sewer Collection System Expansion Phase III Next Steps

An additional 307 homes could have access to sewer service if the Phase III Sanitary Sewer Collection System Local Area Service (LAS) proceeds. The first notice has published in the newspaper (July 27th) and sent to the owners of property within the proposed LAS, regarding Council's intent to establish the LAS and to borrow up to \$2,506,668 to be recovered through a parcel tax on the 307 benefiting properties (those within the LAS). Earlier in 2017, the District signed the Cost Sharing Agreement to receive the joint federal-provincial New Building Canada Fund – Small Communities Fund grant worth \$4,373,332 to fund a majority of the \$6.88 million Phase III Sanitary Sewer Collection System estimated capital cost. Council may proceed with establishing the LAS unless by 4:00 pm on September 5, 2017, Council receives a petition against signed by the owners of at least 50% of the parcels that would be subject to the local service tax and that in total represent at least 50% of the assessed value of the land and improvements subject to the local service tax. No action is required by owners in support. Watch for a report to Council in September. Visit the District website for more info.

Council Update - In July 2017, Council:

- resolved to include \$50,000 in the 2018 budget discussions for Well #5 rehabilitation
- resolved to include the proposed Water Servicing Standards attached to the July 10, 2017 staff report, in the new Water System Service Bylaw for the Community Water System once a reservoir is constructed for the upper zone
- resolved to continue to use the current 3.4 cubic meters per day as identified in Bylaw 55.1 as a standard for any subdivision requiring a private well when a Community Water Connection is not available
- appointed Grant Thornton LLP as the external auditor for 2017-2019, with an option to extend the contract
- approved a grant for the Lantzville Firefighters Association for \$4,500 for fireworks for Hallowe'en
- authorized holding Official Community Plan (OCP)
 Review Select Committee meetings before and after
 the fall public information meeting to provide further
 review and input to Council regarding the draft OCP
- defeated Zoning Amendment Bylaw No. 60.35, to add a Commercial 8 zone and to rezone 7143 Caillet Road from Commercial 1 to Commercial 8 to facilitate future mixed (commercial/residential) development
- gave three readings to Phase III Sanitary Sewer Collection System Local Area Service Establishment Bylaw No. 143, 2017, established a 20-year term for parcel tax, and directed notices to property owners on Council initiative bylaws subject to petition against
- appointed Jon Wilson as Emergency Program Coordinator and alternates Doug Gardiner, Melissa Tomlinson and Fred Spears
- authorized Councillor Will Geselbracht to attend the Union of BC Municipalities' Convention in Vancouver September 25 – 29, 2017
- approved the Economic Development Strategic Plan and Community Branding Select Committee terms of reference, appointed Councillor Geselbracht to the committee, and authorized staff to advertise for other committee representatives and to apply for grant funding.

The Design at Hoots team recently reported that they are busy trying to catch up on projects in Alberta and Ontario, after the late start to the mountain bike park construction season in BC. As soon as there is an opening in the schedule, they are committed to return to Lantzville. Watch for more information on the schedule for development of the mountain bike skills circuit at Rotary Park, on Harby Road East and Peterson Road, tentatively planned for August or September 2017. Bylaw Reminder

Total Fire Ban in Effect – On July 6, 2017, the Fire Chief declared a total fire ban within the District of Lantzville, consistent with the Coastal Fire Centre prohibition. The prohibition is in effect until October 21, 2017 or until the public is otherwise notified. Outdoor burning (including campfires) is NOT permitted on private and public property in the District of Lantzville. This means that any open flame of woody material, use of tiki torches, fireworks, burning barrels, chimeas, outdoor fireplaces and Category 2 & 3 open fires are prohibited. Only devices using fuel that does not create sparks/embers (e.g. propane, natural gas, camp fuel or briquettes) will be allowed. Please avoid using chainsaws, smoking, and other fire hazards in the forest during these extremely dry conditions.

Stage 2 Watering Restrictions - Effective June 1st

The District remains on Stage 2 watering restrictions but encourages conservation to prevent moving to more restrictive stages. Under Stage 2 watering restrictions, sprinkling is permitted between the hours of 7:00 am to 10:00 am OR 7:00 pm to 10:00 pm for a maximum of 2 hours every other day on the following days:

- Odd-numbered addresses on odd-numbered days
- Even-numbered addresses on even-numbered days Sprinkling includes watering lawns, ornamental shrubs, flowers and trees and use of pop-up spray, rotors and sprinklers. Putting in a new lawn? Apply for a new lawn permit. The following are permitted at any time in Stage 2: hand-watering, drip irrigation, and micro irrigation; washing vehicles, boats, and houses (siding) if using a hose with a shutoff device; filling fountains, pools, or hot tubs; pressure washing walkways, driveways and siding. Vegetable gardens and fruit trees are exempt from all watering restrictions, but watering in the early morning or in the evening is recommended due to less evaporation. Private wells are not subject to municipal watering restrictions, but conservation is encouraged because water is a shared resource.

FOOD WASTE, GARBAGE AND RECYCLING

Your regular collection day only changes when there is a statutory holiday. After the August 7th BC Day statutory holiday, your collection day moves to Thursdays for the month of August, starting with recycling and food waste on August 10th. After the September 4th Labour Day holiday, your regular collection day moves to Fridays.
