BENCHMARKING SURVEY

At Council's direction, staff have compiled and added amounts for Lantzville into the attached District of Lillooet 2013 Benchmarking Survey Report. Comparisons between municipalities are inherently difficult; therefore, many of the measures are provided on a "per capita" basis for easier comparability. The financial amounts provided for Lantzville are from the 2013 consolidated financial statements and do not include internal transfers or capital expenditures, consistent with the original survey.

Although the ten communities surveyed are similar in size (populations ranging from 2,142 to 3,601), there are differences in climate (e.g. interior communities have higher winter road maintenance costs), services provided (e.g. recreation facilities, airports) and to whom utilities are provided (e.g. Lantzville sewer and water are provided to only parts of the community). As well, some communities are quite remote, and others have larger neighbouring municipalities that may provide additional services not reflected in the survey costs captured.

Some highlights from the survey analysis with respect to the District of Lantzville comparatives:

- fleet per 1000 residents (excluding fire trucks) is significantly lower than any other municipality;
- Commercial and Industrial tax assessment per capita is significantly lower than the average and all other communities, despite the ratio of these tax rates to the residential rate being higher than others;
- municipal tax levy per capita of \$406 is one of the lowest, and less than half of the average;
- total expenditures per capita of \$557 is the lowest, and approximately one third of the average
- administration costs per capita of \$205 is amongst the lowest of those surveyed, and is 30% less than the average;
- of those surveyed, only Lantzville and Princeton were debt free;
- total staff FTE's per 1000 residents of 2.8 and total staff FTE's of 10.15 were both by far the lowest of the municipalities shown;
- management staff FTE's per 1000 residents of 1.2 was lower than the average of 1.7 FTE's;

In addition to the amounts included in the Lillooet survey, Council requested comparative amounts showing the combined direct Lantzville expenditures and Lantzville's share of the Regional District of Nanaimo and Vancouver Island Regional Library expenditures as follows:

While senior staff salaries were not included in this survey, staff provide some additional analysis with respect to CAO salaries:

- CAO salaries for the surveyed municipalities ranged from \$98,090 to \$128,453, with Lantzville's CAO receiving a salary of \$120,050.
- On a per capita basis, Lantzville is the third lowest in this group at \$33 per capita, and similar to Cumberland (\$31 per capita) which is the closest comparable among those communities included in the survey.
- Amongst all municipalities in B.C. with populations of 2,000 to 4,000, the average CAO salary is \$116,130, with half of the CAO's being paid within the \$119,000 to \$136,000 range.
- The average salary for all municipalities in B.C. is \$138,135, with Lantzville's CAO salary falling at about the 40th percentile in that group.
