Parks & Recreation Commission Brochure & Survey

BC Recycling Program Information

If you have ever wondered where to dispose of your small appliances, fluorescent lighting or and old lawn mower, the Recycling Council of BC has a wealth of information available for BC residents either through their website at www.RCBC.bc.ca or by calling their hotline at 1-800-667-4321. Following is a quick guide to some websites that receive recyclable materials. These websites will include the location nearest to Lantzville that accepts such items.

www.electrorecycle.ca (i.e. small electric appliances, power tools, microwaves, etc.)

www.lightrecycle.ca (i.e. fluorescent tubes, LED, halogen lights, desk lamps, chandeliers, etc.)

www.opec.ca (i.e. electric outdoor equipment, pressure washer, grass trimmer, lawn mowers, etc.)

Low Flush Toilet Rebate Program

Since 2005, the District has offered a low flush toilet rebate program. This program, subject to the District receiving a completed application that meets all the listed requirements, entitles individuals to a rebate of either \$60 or \$100 dollars (depending on the size of the new low flush toilet installed). There is a lifetime limit of 2 toilet rebates per residence.

For new construction, low flush toilets are encouraged and the District will provide a \$40 rebate for those property owners who install dual flush toilets (3/6 litre) as an alternative to the low flush models. There is no maximum for this incentive.

For those residents who are planning on replacing their old toilets with a new low flush model, please obtain an application from the District Office or online (www.lantzville.ca) which then may be submitted to the District Office for reimbursement. **Please read the application form carefully and ensure the following information is included when you submit your application to the District:**

- **Photo of your old toilet in place.**
- **Photo of your old toilet removed with the tank broken.**
- **Photo of your new low flush toilet in place.**
- **Original receipt for a CSA-approved low flush toilet.**

Water Saving Devices for Toilets

Although low flow toilets are the best option, some residents may want to conserve water but do not wish to replace their existing toilets. There are devices available such as the "HydroRight Toilet Converter" or the "Pop Flush" toilet water saver which attach to existing older toilets to convert them to a 3/6 litre dual flush toilet. They can be purchased at local hardware stores for approximately \$20 each. This may be an initiative that Council will consider during its 2013 financial planning process.
