Council Update – In July 2016, Council:

- consented to the Regional District of Nanaimo Board adopting the Southern Community Search and Rescue Contribution Service Amendment Bylaw No. 1552.02
- approved the \$14,000 budget to complete the Development Cost Charges Bylaw review
- adopted the bylaw to enlarge the Lantzville Sanitary Sewer Collection Ph. 2 Local Area Service to add 7468 Lantzville Road
- awarded Lanarc 2015 Consultants Ltd. contracts to conduct the Official Community Plan Review and Update, and to develop a Water Master Plan
- requested and received the District's Harby Road Wellfield rehabilitation update and invited the owners of Well #11 to include (at their cost) the well in the pump testing of the wellfield
- directed staff to develop a draft policy for staff to audio and/or video record in-camera meetings
- announced the Director of Financial Services position increased to full-time for a two-year term
- approved a Development Permit, with variances, to accommodate a new dwelling at 7144 Eby Road
- approved the Remembrance Day road closure (10:00 am to Noon, Friday, November 11th) for the parade to, and ceremony at Huddlestone Park
- instructed the CAO to clarify details of a proposed meeting with the City of Nanaimo about water
- approved the Minetown Day parade road closure (9:45 am to 11:00 am, Saturday, September 10th) of Lantzville Road (Ware Rd to Huddlestone Rd)
- authorized spending donations for Minetown Day

FOOD WASTE, GARBAGE AND RECYCLING

Your regular collection day only changes when there is a statutory holiday. After the August 1st BC Day statutory holiday, your collection day moves to Thursdays for the month of August, starting with recycling and food waste on August 4th. After the September 5th Labour Day holiday, your regular collection day moves to Fridays.

BYLAW REMINDERS

Burning Ban in Effect – Effective May 13, 2016, outdoor burning is NOT permitted in the District of Lantzville. Outdoor burning, backyard burning, bonfire, incinerators, open air fire and burn piles are all referencing fires for the purpose of cleaning up yard debris. Branches, leaves, cuttings and trimmings CANNOT be burned at this time per our bylaw and the Burning Ban imposed by the BC Wildfire Service. **NOTE: The burning ban currently in effect also prohibits the use of fireworks.**

Campfires are still allowed but due to the drying conditions could be banned at any time. A Campfire is defined as any fire smaller than .5 meters high by .5 meters wide burning clean wood used for cooking, heating and ceremonial purposes. It must have someone in attendance and you cannot burn yard debris or prohibited materials. Please fully extinguish any campfire after use, stay a safe distance away from combustibles and be considerate of your neighbors.

Beach Fires follow the basic description of a campfire and will be prohibited once the campfire ban is imposed. The following additional considerations must be followed. Beach fires are only allowed between 06:00am and 11:00pm, they MUST be extinguished fully before 11:00pm and MUST be placed below the high tide line away from combustibles like drift logs. NO PALLETS are to be burned, only clean fire wood.

Please be aware that forest conditions are extremely dry, share the responsibility and do your part in being Fire Safe! Program your phone to assist you in an emergency:

Stage 2 Watering Restrictions – Effective June 1st

Under Stage 2 watering restrictions, sprinkling is permitted between the hours of 7:00 am to 10:00 am **OR** 7:00 pm to 10:00 pm for a **maximum of 2 hours every other day** on the following days:

- Odd-numbered addresses on odd-numbered days
 - Even-numbered addresses on even-numbered days
- Sprinkling includes watering lawns, ornamental shrubs, flowers and trees and use of pop-up spray, rotors and sprinklers. Putting in a new lawn? Apply for a new lawn permit. The following are permitted at any time in Stage 2: hand-watering, drip irrigation, and micro irrigation; washing vehicles, boats, and houses (siding) if using a hose with a shutoff device; filling fountains, pools, or hot tubs; pressure washing walkways, driveways and siding. Vegetable gardens and fruit trees are exempt from all watering restrictions but watering in the early morning or in the evening is recommended – less evaporation. Private wells are not subject to municipal watering restrictions, but conservation is encouraged because water is a shared resource.
