## Happy Victoria Day!

The District Office will be closed Monday, May 22, 2017 for the Victoria Day holiday. Regular office hours (8:00 am – 4:00 pm, Monday to Friday) will resume on Tuesday, May 23, 2017. In case of a public works emergency, please call the after-hours answering service at 250.741.3335, who will contact District staff.

## Property Tax Notices

In late May, the District of Lantzville will mail 2017 property tax notices to property owners, including information regarding payment options, Home Owner Grants and deferment programs. Contact the District Office if you do not receive your tax notice. Property taxes (including the signed Home Owner Grant required annually) must be received on or before the tax due date of Tuesday, July 4, 2017 to avoid a late penalty. A 5 % penalty is assessed on balances outstanding after July 4<sup>th</sup>, and again after September 30<sup>th</sup>. Every year we have taxpayers who must pay a penalty because they fail to claim the Home Owner Grant prior to the due date. Don't let this happen to you!

## Council Update – In April 2017, Council:

- adopted Development Cost Charge Reserve Fund Expenditure Bylaw No. 142
- gave Phase III Sanitary Sewer Collection System Loan Authorization Bylaw No. 144 first three readings
- gave Financial Plan Bylaw No. 136 first three readings
- gave Tax Rates Bylaw No. 137 first three readings
- authorized an annual contribution to the Federation of Canadian Municipalities Legal Defense Fund based on 2 cents per capita (approx. \$87 for 2017)
- appointed Ronald Campbell as CAO, Deputy Director of Corporate Administration and Approving Officer
- appointed all seven members of Council to the Parcel Tax Roll Review Panel, and established the meeting time and place (6:00 pm, May 8, 2017, if required)
- gave Property Tax Prepayment Plan Bylaw No. 145 first three readings
- received and forwarded an Agricultural Land Commission Application for 7071 Schines Place (to accommodate an additional three-lot subdivision) to the ALC without comment

### OCP Update & Water Master Plan Survey

Thank you to everyone who completed and submitted a Community-wide Survey before April 7, 2017. Initial counts show that we received over 350 responses. The submissions are now being tabulated by an independent survey firm and the results will be brought forward in early May. These results will be used as input to the Draft OCP Update and Draft Water Master Plan being developed through the month of May. A community event in the last half of May will be held to discuss the draft plans. Please stay tuned for an announcement with a time and date for this event.

*Highway southbound @ Ware Road*
3. Sunday, May 21<sup>st</sup> 9:30 am – 11:30 am  
*Highway southbound (north of Exit 29) meet at the end of Alger Road*
4. Saturday, May 27<sup>th</sup> 9:30 am – 11:30 am  
*E&N Trail maintenance – Aulds Road end*

### BYLAW REMINDERS

**Outdoor Burning** – Open burning (fire piles on the ground) is not permitted within the District limits from May 15<sup>th</sup> to October 15<sup>th</sup>. The use of incinerators is permitted, subject to a burning permit issued by the Fire Chief, and rules (e.g. requires mesh screening maximum 1 inch), limitations, and permit cancellation due to safety hazard, non-compliance, or wind conditions. Burn as hot as possible to reduce smoke and ash. From October 16<sup>th</sup> to May 14<sup>th</sup>, residents are permitted to burn in their backyards without a permit. Conditions apply. Call the Ministry of Environment at 1.888.281.2992 and follow the prompts to hear Environment Canada's daily ventilation index for Central Vancouver Island to confirm if burning is permitted. Conditions must be GOOD on the day you burn per the burning bylaw. **Fire Rescue Safety Message** – Take a critical look at the property outside of your house for fire hazards. The areas surrounding your home should be free from debris and fire hazards. Wood piles that are beside your home should be moved away for the summer and the wood debris should be raked up and discarded. *Do your part, don't let fire start.*

### Stage 1 Watering Restrictions – Effective May 1<sup>st</sup>

Under the new watering restrictions, in Stage 1, sprinkling is permitted on any day between the hours of 7:00 pm and 7:00 am. Sprinkling includes watering lawns, ornamental shrubs, flowers and trees and use of pop-up spray, rotors and sprinklers. Putting in a new lawn? Apply for a new lawn permit. The following are permitted at any time in Stage 1: hand-watering, drip irrigation, and micro irrigation; washing vehicles, boats, and houses (siding) if using a hose with a shutoff device; filling fountains, pools, or hot tubs; pressure washing walkways, driveways and siding. Vegetable gardens and fruit trees are exempt from all watering restrictions but watering in the early morning or in the evening is recommended – less evaporation. Private wells are not subject to municipal watering restrictions, but conservation is encouraged because water is a shared resource.

**Illegal Dumping** – Each property owner is responsible for disposing of your own grass clippings on your own property through composting, contracting with a private recycling service to pick-up, or taking it to the landfill. It is illegal to dump your grass clippings on right of ways, public property or private property owned by others.

### FOOD WASTE, GARBAGE AND RECYCLING

Your regular collection day only changes when there is a statutory holiday. In May your collection day will be on Mondays until after Victoria Day, when it resumes on Tuesday, May 23, 2017 with recycling and food waste, and continues on Tuesdays until July.
