



## District of Lantzville Permissive Tax Exemption Bylaw Notice

Pursuant to Sections 94 and 227 of the *Community Charter*, notice is hereby given that Council of the District of Lantzville intends to adopt “District of Lantzville 2022 Property Tax Exemption Bylaw No. 286, 2021” by October 31, 2021. This bylaw proposes to exempt from taxation lands and improvements for the 2022 year. The properties being considered and the estimated municipal property taxes for the years 2022-2024 that would be imposed if they were not exempt are listed below.
